



This ordinance is an attempt to codify already existing procedures, and to protect the publicly-owned roadways from unnecessary damages. FIRST READING PASSED BY FISCAL COURT'S MAGISTRATES.

AN ORDINANCE RELATING TO NUISANCE ANIMALS

The County, in an attempt to codify already-existing state statutes as required by law, hereby adopts Kentucky Revised Statute 258.195 (employment of dog warden, etc., and other minimum requirements mandated by the State of Kentucky. RIST READING PASSED BY RISCAL COURT'S MAGISTRATES.

AN ORDINANCE RELATING TO THE PROTECTION OF PUBLIC PROPERTY

The County, in an effort to protect publicly-owned property (street signs, buildings, grunds, etc.), defines vandalism as any wanton act of destruction, defacement, or theft, partial or complete. Requires the County Stromey to vigorously prosecute such actions to fullest extent of state law, and provides, in lieu of a fine, the convicted person to <u>submit himself/herself to Community Service labor</u> on County projects as directed by the magistrates and county judge executive (work detail). AN ORDINANCE RELATING TO LOCAL GOVERNMENT IMPLEMENTATION OF A FRANCHISE UPON INSURANCE COMPANIES

AN ORDINANCE RELATING TO CONTROLLING ENVIRONMENTAL POLLUTION CAUSED BY INADEQUATE SEWAGE SYSTEMS

The County, in an effort to protect and enhance the health standards of the citizens of Rockcastle, and to protect the environment from unnecessary pollution caused by persons constructing homes in Rockcastle County <u>without</u> sewage systems (septic tanks, etc.), would require homeowners to follow state Department for Natural Resources administrative regulations, requiring said homeowners (<u>new</u> <u>construction only</u>) to receive a permit from the local health board before electrical utility service could be

This ordinance would have placed Rockcastle County in compliance with every other county within the Cumberland Valley Board of Health District. FIRST READING FAILED BY THE FISCAL COURT. (Two ayes;
