RCIDA closes on property for new business

In their regular monthly meeting, the RCIDA board approved authorization for the closing on property in the new Rockcastle Business Park South, making way for a new business to locate there.

Representatives of RCIDA and Weltrans signed documents this week which transfers to the company a one acre parcel in the park for their new business. The closing has been delayed several weeks due to difficulties in gaining a clear title to the property because no official survey had been done of the interior property. Surveyors had to comb through several documents, including water and sewer easements.




Memorial Tradition Remains Alive in Rockcastle

This season of the year marks the tradition of "Decoration Day" or Memorial Day as it has come to be known. Here in Rockcastle County, as well as other towns and counties all over the country still celebrate the day much like it was originally. Some choose dates other than the federal holiday to honor their dead. It is an age-old tradition going back for several generations, back to the horse and wagon days, the age of hand-crafted flowers, and the days of "dinner on the ground". It's a family tradition that I look to with anticipation each year.

Memorial Day, or Decoration Day, as it was originally called, was celebrated on the last Monday of May. It was designed to honor those who served in the Civil War. It was only in 1971 that it became a federal holiday, more than a hundred years after the end of the Civil War. (History.com/topics)

Several womens groups of the South had begun to "decorate" the graves of the Confederates before the end of the Civil War. A hymn written in 1867, "Kneel Where Our Loves are Sleeping", by Nella L. Sweet was "dedicated to the Ladies of the South who are decorating the graves of the Con-



Bizarre Weather

What in the world is going on with the weather this year? According to the National Weather Service, this is the deadliest year for tornadoes in the United States since 1950. Severe storms in the early spring in Kentucky produced one of the wettest Aprils on record. The Ohio River near Louisville crested at over 55 feet, closing in on the record of 60 feet which occurred in 1937. Historic lake levels have been reported across the Commonwealth. In addition, the Kentucky Transportation Cabinet reports that this spring approximately 250 roads were closed due to weather-related problems.

If my grandmother (Mommie Katie) was still alive, she would most cer-

tainly say that these storms, tornadoes, and flooding are a "sign of the times." She would announce a warning to family and friends, "You better get ready for the coming of the Lord." I am about to agree with her.

In my lifetime, I have not seen such destruction across the United States caused by natural weather disasters. I cannot help but compare this trend in the weather to the conditions in Rockcastle County when I was a young boy, where we endured

County should try different tack to decrease jail expenses...

Our devoted and competent county attorney, Billy Reynolds, says that since the state has decided to hold fewer nonviolent Kentuckians in prisons, our jail may lose the money it makes housing state inmates (Signal front page, May 5, Rockcastle draft budget). To make money by holding sons and daughters captive is always sickening, so it is good that we may be forced to do less of it. But Jailer Haddix says that when these profitable state prisoners leave, they will perform better by replacing them with an equal number of county prisoners that don't pay a profit.

As the article says, Rockcastle can't do anything about the state's reduction in prisoners, but we can mitigate the general fund's liability to the jail. We could run our jail at 50% capacity. Simply say a fond farewell to the lucrative state prisoners and do not increase the number of financially burdensome county prisoners. This would decrease our general fund's obligation for medical care, food and administration of the additional inmates. It would mean more individual attention available for rehabilitation programs.

To hold fewer mothers and fathers behind bars is a good thing, especially when it saves the county money. What an opportunity! How delightful it would be to appear as a county leader before the judgment seat and have it announced that your county made the unheard of decision to run your lockup at 50% rather than 110%.

drink coffee and he made it strong and my mom said you had to be 18 before you could drink coffee. I never once told on Uncle Stevie even though I'd go home sometimes and Mom would ask why I had the jitters.

The hill was high and steep, almost straight up and down, to get into the big woods to the ridges that rinked Blair Branch. You had to grab hold of one little sapling after another and sort of pull yourself up until you got to walking ground and then Uncle Stevie would put a finger to his lips and go “sheeeeeeeeee.” And we would sneak through the woods looking for game.

He never paid any attention to the hunting seasons. If it was stirring around, Uncle Stevie figured it was as in season as it ever would be and he thought that squirrels tasted a lot better when they were fattening on mullberries in the spring of the year than when they were on hickory nuts and acorns in the fall. And he was right. Aunt Nan would cook the spring shot squirrels and the meat was sweeter than anything ever killed in season.

My Aunt Nan was a little woman and all her recipes were just hers. She used way too much baking soda in her biscuits and cornbread to suit me but anything else she fixed was beyond perfection. I can close my eyes right now and taste her morning gravy made on bacon or homemade sausage, so unique and wonderful that the oversodaed biscuits hardly crossed your mind. And she was a genius on anything pork or game.

I have written here several times, that my favorite meal of all time is squirrel gravy and sweet potatoes.

Aunt Nan is the only person who ever made that meal properly and her recipe would rival anything in a 5 star French restaurant. I stand by the claim.

And I don't believe you want any recipes for ground hog even though Uncle Stevie kept Aunt Nan busy.

But Uncle Stevie really hunted ground hogs just this time of year when we got on top of the hill. He called them whistle pigs and they were heavy to carry for a school boy. But one is all we needed. Thank you, Lord.

first Decoration Day was held on May 30, 1868, where flowers were placed on the graves of the Confederate and Union soldiers at Arlington National Cemetery. The South refused to honor the day, but chose another day until after World War I, where the holiday was changed to honor all military dead. Some southern states yet insist on a separate day to honor the Confederate dead; they are Texas on January 19, Alabama on April 26, Florida, Georgia, Mississippi, South Carolina on May 10, and Louisiana and Tennessee on June 3.

Some of my earliest memories are of going to the Decorations at Freedom and Skaggs' Creek. It was a family tradition that had been around for a long time by the time I came along. (Of course, other cemeteries all over the country held similar celebrations.) Our family would pack a big picnic lunch and head to the cemetery (Freedom on the 30th and Skaggs' Creek the following Sunday). We would take along flowers for all of the relative's graves. After we ate a big meal, we'd decorate the graves. It was a particularly rewarding day for my brother, Don; it was the only day of the year he got all of the deviled eggs he could eat. As kids, we enjoyed the food more than anything else.

Many years ago, my great-grandma Norton and her daughters made flowers out of paper mache during the long, cold winters for use at Decoration. They also took live flowers from the yard, too. I'm sure was the case of all our families during a certain era here in the county.

The food is a tradition, as well. It always had, and still does, have a Southern flair. You can always count on skillet-fried chicken, cured hams, chicken and dumplings, baked beans, green beans, “cut off” corn, pies and cakes of every sort, and of course, the deviled eggs. As we decorated the graves after lunch, we would run into other relatives... “Well, I want you to look! Here is 'so-and-so'. I haven't seen you since last year. How have you all been?” This was always accompanied with a big, genuine laugh and a hug around the neck. “Now, Tonya, this is your aunt- or uncle- (usually a great-) or a second or third cousin.” I'd be standing there a little past knee-high expected to remember all this.

Traditional Memorial Day has diminished over the years. (The younger generations, even in my family feel that it has no meaning.) At many cemeteries, the graves of the fallen are increasingly ignored and have come to be in a state of disrepair. People have forgotten the flag, and proper etiquette for the day. Memorial Day parades are a thing of the past. Thankfully, Mount Vernon still has a Memorial Day program and wreath-laying ceremony.

A resolution was passed in December of 2000, the National Moment of Remembrance. It asks that at 3:00 PM local time, all Americans to voluntarily and informally observe in their own way a moment of remembrance and respect, pausing from whatever they're doing for a moment of silence or to listen to “Taps”.

The wearing of red poppies on Memorial Day comes from a poem written by Moina Michael.

“We cherish, too, the poppy red

That grows on fields where valor lies

It serves to signal the skies

That blood of heroes never dies.”

plenty of storms but never of the magnitude that we see reported today.

Since we lived on one of the highest spots in the county, we frequently had severe thunder storms, producing lightning which commonly struck many of our tall popular trees. I witnessed 100-foot trees split into two because of these electrical storms. Once lightning actually struck my grandparent's house while we were sitting on the couch waiting for the storm to pass. The electrical energy caused the fuse box in the kitchen to explode; parts of that metal box flew all over the house. I am here to tell you that being in a structure that is hit by lightning is no fun at all.

Because of the frequent electrical storms in our area, my family usually took refuge in the cellar where our canned vegetables and fruit were stored. Mommie Katie took charge as the guardian of the door and was the one to report when we could safely return to the house. If she thought there was any potential that additional electrical activity was possible, we stayed inside that old, dark, damp underground room. Occasionally, I would hear her saying prayers under her breath.

I distinctly remember one time when a severe storm was approaching, and we had company for a Saturday dinner. They were kin folks from Griffin, Georgia.

When the storm came over the horizon, Mommie Katie ushered all of us into that tiny room to keep us safe. That was not a fun way to spend a Saturday afternoon, and I don't think that our company was too pleased with Mommie Katie holding them captive underground. Of course, as soon as the storm passed, we returned to the dinner table to indulge in the family meal.

I also have a clear memory of another storm that occurred when I was a teenager. Gary Foster and I, along with a couple of other friends, decided to spend the day at Big Fill Cave. We hauled our food and drinks down the Louisville and Nashville railroad tracks, planning some fun exploring the cave and enjoying our supply of goodies.

As teenage boys often do, we decided to eat first. We proceeded to build a nice fire in the mouth of that big old cave. While we were roasting hotdogs using sticks, we heard the rumble of an approaching storm. In no time at all, that storm broke loose with lightening and thunder like I had never heard. We pulled back into the cave for refuge but not so far that we could not watch the electrical display. All of a sudden, the rain began to fall in sheets, and the wind started to blow inside the cave. Deeper and deeper we withdrew in order to stay out of “harms way.”

This went on for about an hour, when someone asked, “How are we going to get back to Mt. Vernon if this storm doesn't let up?” We decided that since our parents knew where we were spending the day, they would know that that big old cave was about as safe a place as we could ask for; we would just wait out the storm.

We did have a transistor radio and could stay close enough to the opening to maintain a signal, so we listened to our music to keep us occupied. Finally, just before dark, the storm subsided. We lit out for our cars which we had parked at the Dinner Bell Restaurant. Looking back, that was a quite a pleasant way to spend a stormy Saturday afternoon.

My final recollection of a storm story occurred one night when I had a date with Barbara Sue Mullins. We had made plans to see a movie at the Valley Drive In Theater. Before we got there, a thunderstorm approached, and we decided to drive around to see if it would pass in time for the movie to begin. While driving toward Renfro Valley from Mt. Vernon, lightening smacked a tree right in front of my 58 Chevy; fire exploded all along the side of the road. You never saw two teenagers so terrified. To this day, I clearly recall the sight and the smell of that burning tree.

As for these days, I am hopeful that the weather will calm down for the rest of the summer but I certainly would not bet on it. The forecasters persist in warning about record high temperatures (ugh!) and the consequences they can bring. As for me, the only good thing about a thunderstorm passing over is that it often causes the temperature to moderate. As I get older, the heat seems to be harder and harder to tolerate. My ideal summer would be an occasional slow rain, mostly sunny days, and temperatures no higher than the lower 80's.

But I digress. Even though there were tornadoes that caused serious destruction back in my day, I certainly don't recall any of them blowing an entire town off the map. The tornadoes this year have seemed to be almost relentless. And they most assuredly let us know what tremendous power nature can toss our way – and how helpless we are to do anything about it. I already wish I had Mommie Katie's cellar on my little piece of property on Furnace Mountain – just in case.

Agricultural News

County Committee Nominations Open June 15
Farmers, ranchers and other agricultural producers have until August 1 to nominate eligible candidates to serve on the local Farm service Agency county committees.

FSA county committees make decisions on commodity price support loans, conservation programs, disaster programs, employing County Executive Directors and other significant agricultural issues.

To hold office as a county committee member, a person must participate or cooperate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area (LAA) in which the person is a candidate. A complete list eligibility requirement is posted online at: http://www.fsa.usda.gov/Interent/FSA_File/fsa_ccelectuibs_2011.pdf.

Rockcastle County local administrative area (LAA#3) is the area eligible for nominations. This area is the northeast and southeast section of Rockcastle County bound by Garrard, Madison, Jackson and Laurel County. Highways include Little Hurricane Rd, I-75 and US HWY 25.

Individuals may nominate themselves or others as candidates. Additionally, organizations representing minorities and women may nominate candidates. All nominees must sign nomination form FSA-669A, which includes a statement that the nominee agrees to service if elected. Form FSA-669A is available at USDA Service Centers and online at: <http://forms.sc.egov.usda.gov/>

All nomination forms for the 2011 election must be postmarked or received in the local USDA Service Center by close of business on August 1, 2011.

Adjusted Gross Income Consent Forms

In order to receive USDA program payments, each payment recipient must have an Adjusted Gross Income (AGI) verification consent form on file with the Internal Revenue Service (IRS).

The consent form authorizes IRS to verify for FSA whether a payment recipient's AGI meet the eligibility requirements for FSA programs.

Beginning with the 2009 crop year this form became a requirement. However; IRS and USDA reports show that nationwide FSA is still missing the required consent forms from many producers for the 2009 and 2010 crop years. In order to avoid an interruption of program payments, producers need to check and turn these forms in to the IRS immediately if they have not done so.

IRS requires written consent from producers before verification of the average AGI can be provided to USDA. Producers receiving USDA payments must submit completed form CCC-927 to the IRS or producers will not receive USDA program payments and may be required to repay payments received for crop years 2009 and/or 2010.

ments, to ascertain the exact property lines for the one acre parcel.

Due to the amount of time and energy spent on getting a clear title to this property, RCIDA Director Holly Hopkins asked the board if it would be possible to go ahead and do a survey of the entire interior of the park, according to the layout from the master plan. With that, Hopkins said, potential customers would have a clear title to the property they were interested in, if they wanted to purchase a lot that wasn't different than what was on the master plan.

“The authority would still have to have a survey done for any potential customers that wanted a lot size that wasn't on the master plan,” said Hopkins, “but we would already know where everything in the park is and would have clear titles to the property also. It would expedite the process for a potential client, which always works in our favor.”

The board agreed that the survey of the interior of the park needed to be done and gave Hopkins permission to seek out a surveyor for the job.

of the window, woke Bell who went to investigate the noise. Hembree confronted her and began beating her with a flashlight before leaving the scene.





Angie and James Poynter. Alaina is the daughter of Jason and Sara Coguer. Both are from Mt. Vernon.



A source water assessment has been performed to identify land use which may impact the water supply. The primary sources of contamination are agriculture, onsite septic systems, and roadways. Activities and land uses upstream of Mt Vernon Water Work's source of water can pose potential risks to your drinking water. Under certain circumstances contaminants could be released that would pose challenges to water treatment, or even get into your drinking water. These activities, and how they are conducted, are of interest to the entire community because they potentially affect your health and cost of treating your water. Activities immediately upstream or your water supply intake are of special concern because they provide little response time to the water system operators. An analysis of the susceptibility of the Mt Vernon water supply to contamination indicates that this susceptibility is generally moderate.

Below are the Management Recommendations for land and coverage: (1) Monitor to ensure compliance with Forestry Conservation Act. (2) Require BMP (Best Management Practices) implementation per the Forest Landowners Handbook. Agriculture: (1) Monitor annually to ensure compliance with Agriculture Water Quality Act (AWQA); (2) Encourage implementation of voluntary BMPs above the minimum required by the AWQA. BMP manuals for specific types of operations are available; (3) monitor annually to ensure implementation of Nutrient Management System (NMS); (4) Encourage development and implementation of Resource Management Plans (RMS) on agriculture operations per USDS-Natural Resource Conservation Service (NRCS) Specifications; and (5) No storage or use of pesticides. Highways maintenance and runoff/Railroads: (1) require the adoption and application of highways maintenance and runoff BMP; (2) Limit highway construction or avoid waterways. Modify designs to limit runoff, especially drain-spouts on bridges to minimize salt deicing runoff to waterways; and

(3) encourage posting of signs indication presence of source water protection area on major roads. Onsite/Decentralized/Septic Systems, Straight Pipes: (1) Eliminate and prevent new straight pipes and failing septic systems; (2) Prepare and implement Groundwater Protection plan; conduct monitoring activities to assess effectiveness; (3) connect proper maintenance of system; (5) Replace failing onsite systems; (6) reduce generation of wastewater; (7) conduct education and training for local officials and general public regarding onsite wastewater issues; (8) Adopt region planning and management wastewater. This report is designed to inform the public about the quality of water and services provided on a daily basis. Our commitment is to provide a safe, clean, and reliable supply of drinking water. We want to assure that we will continue to monitor, improve, and protect the water system and deliver a high quality product.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and may pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants, such as viruses and bacteria, (sewage plants, septic systems, livestock operations, or wildlife). Inorganic contaminants, such as salts and metals, (naturally occurring or from stormwater runoff, wastewater discharges, oil and gas production, mining, or farming). Pesticides and herbicides, (stormwater runoff, agriculture or residential uses). Organic chemical contaminants, including synthetic and volatile organic chemicals, (by-products of industrial processes and petroleum production, or from gas stations, stormwater runoff, or septic systems). Radioactive contaminants, (naturally occurring or from oil and gas production or mining activities). In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water to provide the same protection for public health. Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people

should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Some or all of these definitions may be found in this report: **Maximum Contaminant Level (MCL)** - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology. **Maximum Contaminant Level Goal (MCLG)** - the level of a drinking water disinfectant below which there is no known or expected risk to health. MCLGs allow for a margin of safety. **Maximum Residual Disinfectant Level (MRDL)** - the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants. **Maximum Residual Disinfectant Level Goal (MRDLG)** - the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants. **Below Detection Levels (BDL)** - laboratory analysis indicates that the contaminant is not present. **Not Applicable (N/A)** - does not apply. **Parts per million (ppm)** - or milligrams per liter, (mg/L). One part per million corresponds to one minute in two years or a single penny in \$10,000. **Parts per billion (ppb)** - or micrograms per liter, (µg/L). One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000. **Parts per trillion (ppt)** - one part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000. **Parts per quadrillion (ppq)** - one part per quadrillion corresponds to one minute in 2,000,000,000 years or one penny in \$10,000,000,000,000. **Picocuries per liter (pCi/L)** - a measure of the radioactivity in water. **Millirems per year (mrem/yr)** - measure of radiation absorbed by the body. **Million Fibers per Liter (MFL)** - a measure of the presence of asbestos fibers that are longer than 10 micrometers. **Nephelometric Turbidity Unit (NTU)** - a measure of the clarity of water. Turbidity has no health effects. However, turbidity can provide a medium for microbial growth. Turbidity is monitored because it is a good indicator of the effectiveness of the filtration system. **Variations & Exemptions (V&E)** - State or EPA permission not to meet an MCL or a treatment technique under certain conditions. **Action Level (AL)** - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system shall follow. **Treatment Technique (TT)** - a required process intended to reduce the level of a contaminant in drinking water.

Information About Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Your local public water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. 

Local – It's a renewed (and renewable) economic engine

No one has to explain "local" to folks in Somerset, Kentucky. For generations, we've taken sustenance from the fields, streams and lakes surrounding our community. Many families still know the taste of a fresh fish or of wild game. And, many families know just what a tomato that has never been boxed and refrigerated tastes like. That dependence on local extends to our businesses as well. We've always preferred to "buy local" even before this became a national buzz word. The Kentucky Department of Agriculture has recognized the value of promoting local fresh foods from local farms with programs like "Kentucky Proud" and the Kentucky Roadside Farm Market program. Owens Garden Center is proud to participate in both of these initiatives.

There are many channels for folks in Somerset to acquire fresh food for their table and fresh plants for their garden. All of these channels have merit. Not all of these channels, however, can boast the local pride of placing money in the community that is estimated to move through 13 LOCAL transactions. So, when you plan your vegetable garden or flower beds or patio baskets, think local. I invite you to visit all the local garden centers and farm markets. Just remember, when you hand your money to a local merchant, that money is the beginning of a complete cycle of support for our local economy. As you admire your garden this summer, take pride that you and your community are growing together.

Mamaw's Kitchen

PEPPERY CUCUMBERS

Every time I peel a cucumber, and prepare it this way, I put a very liberal amount of black pepper on them. And every time I do this, I hear Aunt Doris telling me that was the way Uncle Walker liked them best. I remember many times going into the garden behind their house in Danville; picking cucumbers (among other vegetables) that Aunt Doris needed to prepare for dinner. Cucumbers were, and still are, my favorite. I don't always put onions in them the way we used to, but I do put the pepper on them.

5 medium cucumbers, peeled, thinly sliced
1 medium onion, thinly sliced
1 teaspoon salt
1 teaspoon black pepper (or more)

1/2 cup apple cider vinegar
1/2 cup water

Put cucumbers and onions in bowl. Sprinkle with salt and pepper. Add vinegar and water. Gently toss to cover vegetables. This can be served right away or, if desired, let marinate for a couple of hours. Can be served chilled or at room temperature. If not eating soon, you might want to add a teaspoon vegetable oil.

This will keep the cucumbers and onions crispy.

MUM'S FRIED GREEN TOMATOES

4 large green tomatoes
1 cup self-rising cornmeal mix
Salt and Pepper
1/4 cup bacon grease or oil
Sugar, optional
Slice tomatoes into 1/4-inch slices. Mix cornmeal with salt and pepper to taste. Dredge tomato slices in cornmeal. Heat bacon grease in heavy skillet over medium-high heat. Place tomato slices in hot grease. Fry about 5 minutes on each side until browned. Drain on paper towels. Sprinkle with sugar if desired.

GRANNY BURTON'S COLESLAW

Because I love green pepper and cucumbers, this is my favorite version of coleslaw.

1 small head green cabbage
1 large carrot
1 green bell pepper
1 large cucumber
1 cup Miracle Whip®
1/3 to 1/2 cup milk
2 tablespoons sugar
Salt and pepper to taste
Finely shred or chop vegetables. Best if a food processor is used. Mix Miracle Whip®, milk, sugar, salt, and pepper until smooth. Stir into cabbage mixture.

RECOVERY BY ENVIRONMENTAL SURCHARGE OF
KENTUCKY UTILITIES COMPANY'S 2011 ENVIRONMENTAL COMPLIANCE PLAN**

PLEASE TAKE NOTICE that on June 1, 2011, Kentucky Utilities Company ("KU") filed with the Kentucky Public Service Commission ("Commission") in Case No. 2011-00161, an Application pursuant to Kentucky Revised Statute 278.183 for approval of an amended compliance plan ("KU's 2011 Environmental Compliance Plan") for the purpose of recovering the capital costs and operation and maintenance costs associated with new pollution control facilities through an increase in the environmental surcharge on customers' bills beginning January 31, 2012 under KU's existing Electric Rate Schedule ECR, also known as the environmental cost recovery surcharge.

Federal, state, and local environmental regulations require KU to build and upgrade equipment and facilities to operate in an environmentally sound manner. Specifically, KU is seeking Commission approval of Certificates of Public Convenience and Necessity ("CPCN") to construct new Particulate Matter Control Systems to serve all units at the Ghent Generating Station in Ghent, Kentucky, and to serve all units at the E.W. Brown Generating Station in Burgin, Kentucky, to comply with the national emissions standards for hazardous air pollutants proposed by the U.S. Environmental Protection Agency ("EPA"). The Particulate Matter Control Systems are also being installed to comply with EPA-imposed sulfuric acid mist and opacity requirements. Additionally, KU is seeking recovery of costs associated with these environmental projects, which are necessary for compliance with the federal Clean Air Act, the federal Resource Conservation and Recovery Act, and other current or proposed environmental laws and regulations, and enforcement actions. These additional projects primarily relate to installing Particulate Matter Control Systems to serve all units at the Ghent Generating Station, installing Particulate Matter Control Systems to serve all units at the E.W. Brown Generating Station, converting the main coal combustion residuals treatment basin at the E.W. Brown Generating Station to a landfill and other pollution control facilities. The capital cost of the new pollution control facilities for which KU is seeking recovery at this time is estimated to be \$1.1 billion. Additional operation and maintenance expenses will be incurred for these projects and are costs that KU is requesting to recover through the environmental surcharge in its application.

The impact on KU's customers is estimated to be a 1.5% increase in 2012 with a maximum increase of 12.2% in 2016. For a KU residential customer using 1,000 kilowatt hours per month, the initial monthly increase is expected to be \$1.13 during 2012, with the maximum monthly increase expected to be \$9.46 during 2016.

The Environmental Surcharge Application described in this Notice is proposed by KU. However, the Public Service Commission may issue an order modifying or denying KU's Environmental Surcharge Application. Such action may result in an environmental surcharge for consumers other than the environmental surcharge described in this Notice.

Any corporation, association, body politic or person may, by motion within thirty (30) days after publication, request leave to intervene in Case No. 2011-00161. That motion shall be submitted to the Public Service Commission, 211 Sower Blvd., P.O. Box 615, Frankfort, Kentucky, 40602, and shall set forth the grounds for the request including the status and interest of the party. Intervenor may obtain copies of the Application and testimony by contacting Kentucky Utilities Company at 220 West Main Street, Louisville, Kentucky, 40202, Attention: Lonnie E. Bellar, Vice President, State Regulation and Rates. A copy of the Application and testimony will be available for public inspection on KU's website (<http://www.lge-ku.com>) and at KU's offices where bills are paid after June 1, 2011.
