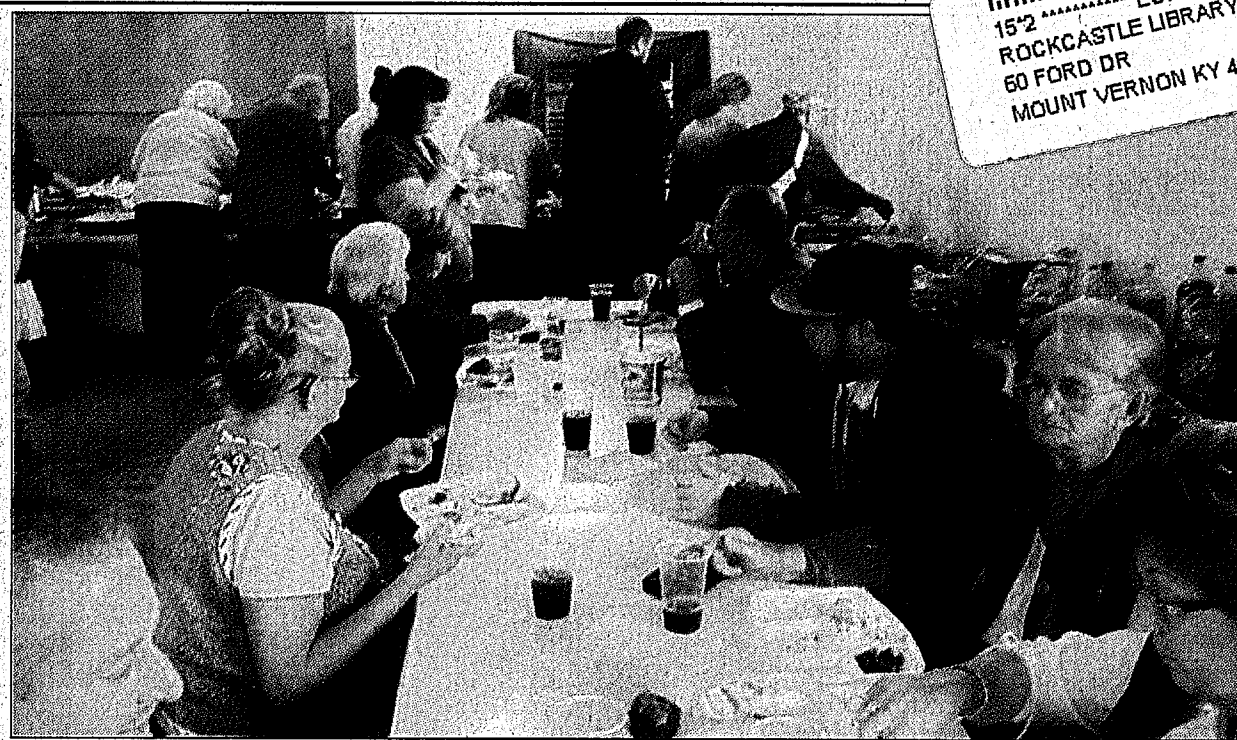

## Grant agreement; land purchase on court agenda

The fiscal court formalized their recent agreement to support the City of Livingston in their application for grants Monday, at a special meeting, by approving a resolution and agreement for the project to renovate the former Livingston school which is owned by the county.

asked if it would be legal for the county to donate the school building to the city of Livingston. County Judge/Executive Buzz Carloftis said that property could be conveyed from one government entity to another but he would rather see a board set up to oversee the property made up of some members of the fiscal court, some members of the Livingston city commission and citizens of Livingston," Carloftis told the court.

The action was necessary to initiate proceedings to secure a CDBG grant for \$500,000 for the Livingston School project. The project will be overseen by the city and the grant writers, a private firm.

However, Magistrate Bill McKinney questioned why another committee would be necessary since the court already has an infrastructure committee in place that regulates and oversees all county prop-

The city is also applying for a \$250,000 Appalachian Regional Commission grant to repair and renovate the city-owned Forster Mullins building. Both grants are 100% grants.

## Road construction project now completed on I-75

Contractors recently completed the large-scale road construction project on I-75 northbound and southbound between the 58' and 66 mile markers in Rockcastle County.

The I-75 construction project began in July when the KTC reduced both I-75 northbound and southbound to one lane between the 58 and 66 mile markers while crews repaved lanes, repaired drains, repaved exit ramps, replaced guardrails, repaved emergency lanes

## Controversy still stirring over county salt supply

Some Rockcastle Countians are expressing concerns about the county's alleged minimal salt supply that is needed to treat the roadways in inclement weather.

ton. He said each county in Kentucky bids and orders salt through a reverse auction each summer and that it's based on supply and demand as well as each entity's salt usage from the prior year.

Carloftis said when last Tuesday's snowstorm came, the county still hadn't received any of their ordered salt but that they had approximately 20 tons of salt left in storage which was the equivalent to one dump

truck load. He said the county always sells salt to the City of Mt. Vernon and that they sold them 10 tons or one small dump truck load.

However, he said the county received 125 tons of their order last Tuesday afternoon, and that they will hopefully receive the remainder of their order in the near future.

Several people called the Signal last week, claiming the county road crews supposedly only had enough salt to fill up "one dump truck."

Carloftis said the county's salt supplier told them that there was a nationwide shortage of salt because of the record amounts used last winter. He said that no actual arrival date was given for any of their salt order but that he hoped to receive some of it before the first snowstorm of the win-

He said these types of scams have existed for years but that they are becoming more prominent with the upcoming holiday season.

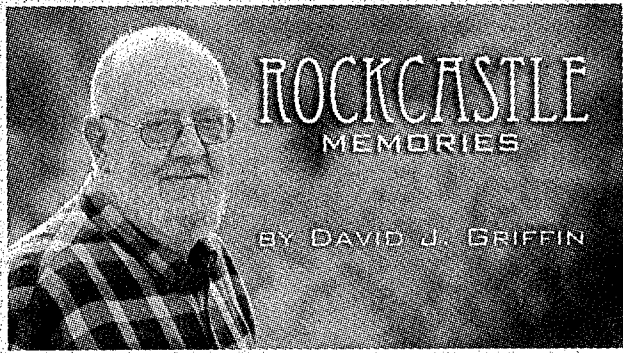

**Bee's Dutch Oven**

It certainly seems to me that we are experiencing an awfully early change from fall into spring. That, along with the first frost covering our back deck, prompted my wife to suggest that it was time to make the annual exchange of summer clothes for winter attire.

Due to the fact that we have practically no storage space in our small house, we use our backyard storage building to warehouse our out-of-season apparel. Therefore, it was time to start hauling the clothing out to the storage building. Upon opening the door to enter, I spotted mother's (Bee to my weekly readers.) Dutch oven sitting in the front corner. Boy, did that bring back a rush of memories! After we finished "packing" (as country folk say) the boxes of winter clothing into the house, I started thinking about my mother and her using that Old Dutch oven.

When I was young, Bee cooked our meals on a

wood-burning / kitchen stove. Of course, a Dutch oven is a very handy way to both cook and to serve. Bee loved hers, and she used it on a regular basis. I suppose that my favorite meal from that old oven was her beef stew. It would take almost all day long to cook, and the house would become filled with the warm, delightful aroma of homemade stew.

Actually, whenever I saw her get out that big cast-iron oven in order to cook, I knew I was in for a treat. Sometimes she would use it for good ol' soup beans prepared with a ham-hock. I loved that meal, but who doesn't like soup beans? (Anyone who grows up in the southern part of the U.S. has been raised on soup beans, haven't they?) But Bee used her Dutch oven for baking, too. Once, I watched her make biscuits in it.

I was reading about Dutch ovens recently and found out that they have been used since colonial days in the United States -

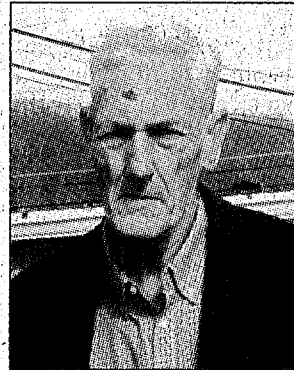

I will see you on the other side where no battles are fought until that great judgment day.

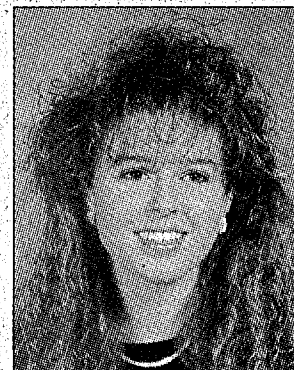

Mom will see you soon, Donna, just wait a little while.

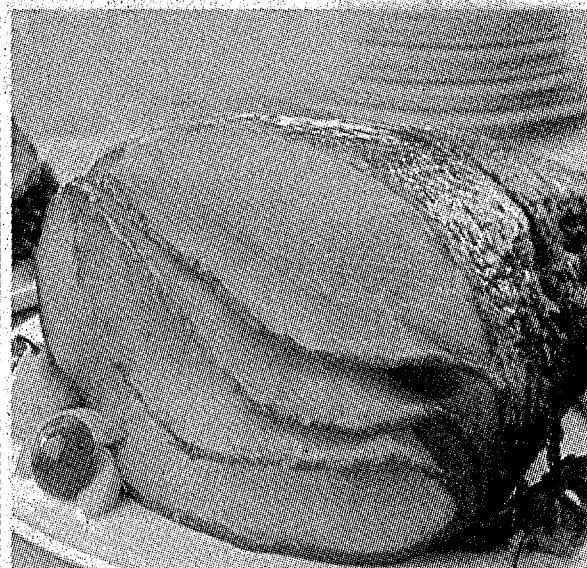

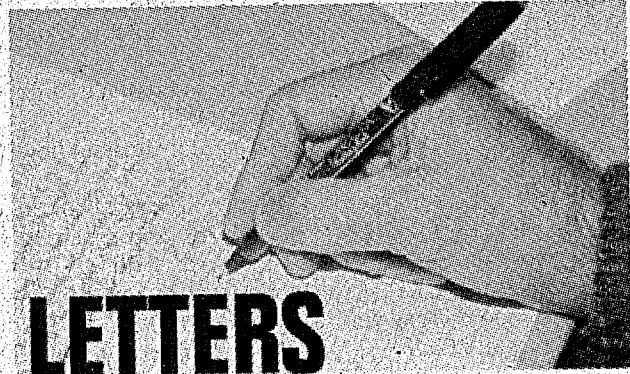

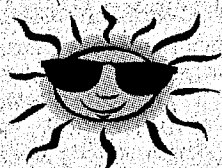

## Thanksgivings To Remember

Dear Journal,  
Thanksgiving is upon us again and all of the wonderful things that go with it. There is the gobs and gobs of food, the football, the parades, and the guests we haven't seen since last year. The best thing about Thanksgiving, for me, is being with family and recalling the holidays of long ago.

We will be having our dinner at my brother, Don's, house this year and most of the family will be on hand, too. We will be having ham, turkey, and all of the sides. There are some things that are old time favorites. Our "Grandma Otey's" dressing is a must. She is my great-great-grandma that died of a heart attack on Thanksgiving afternoon in 1923 probably from all of the stress and strain at her age and not having the modern conveniences of today would be my guess.

Her dressing recipe lives on in the minds and hungry mouths of her kin in generations yet to come. I will have the honor to prepare it this year.

When I was a little girl growing up, the holidays were special. We always gathered at my Grandpa and Grandma Norton's house which was only next door. My mom and grandma really put on a meal. A snowy white linen tablecloth was put on the dining room table along with the napkins and the very best china, silverware, and other glassware. When I was old enough, I was usually called on to do the setting of the table. I helped with the cooking, too. This is how I never use a recipe in making the old family dishes. I was standing there too many times when they were made.

Pretty soon the guests would begin to arrive. Here would come aunts, uncles, and cousins of every sort and sometimes family friends. Uncle Raymond would come in at the back door. He was my grandma's brother and accustomed to

the famous dressing. He would say, even before saying hello, "Well, Evelyn," while still holding the door knob, "have you got any dressing?" She always assured him that she had plenty. He always declared that "after you're gone there'll never be any more dressing." (I made a pan of biscuits one time when he was visiting when I was about sixteen. He kept tasting and tasting, smacking his lips after every bite. He finally said that they were the best biscuits he had ever eaten... "even better than mama made and I thought she made the best there was out there.") There was the "big table" and although I was a child, I got to eat there...and trusted not to break the china and crystal.

I sure remember those days but the thing that made them so special, to look back now, is the family that gathered around that old table. All of them are gone now and only their memory remains, and that exists in the mind of Don and myself. We always seem to drift into conversations about this or that relative that is now long gone every time we talk and how things used to be.

Even the "old homeplace" is gone into the hands of another family. The last family gathering held there was the Thanksgiving of 2010, when my niece Sandy was still living. That old home could recall a lot of living done under its roof. During the holidays, my mind often is found wandering back to this "old lady" who housed several generations of our family. I feel especially blessed to have had this childhood and these special memories... very thankful.

This Thanksgiving will be special in it's our right and we owe the new generations special memories to look back on in their waning years, but for some of us there will be forever more vacant chairs at the dinner table and special memories of the days gone by.

a fact that I had not considered. I suppose that Dutch ovens probably have a significant history in our country.

Of course, many people are familiar with these old iron pots simply from watching western movies or TV. You've seen them in portrayals of women cooking in their pioneer log homes by hanging the oven inside a large fireplace. And, of course, our countless cowboy heroes always had one while on the long trails.

Nearly any depiction of cowboys or wagon trains includes sitting around a campfire with a Dutch oven hanging over the fire. They were a part of the cook's utensils, and a trail cook always had one tucked away in the "chuck wagon." Anyone who is a fan of westerns can remember seeing Gene Autry, Roy Rogers, and numerous other Western heroes on TV squatting beside the campfire dipping beans out of Dutch ovens.

Most of the older ovens had a slightly rimmed lid in order to accommodate hot coals being placed on the oven top to even out the heat. By using this method, these pots could be used to bake various types of bread, including cornbread, biscuits, and even cakes. The bail enabled it to be hung over fires - indoors or out. Mine does not have the rimmed top but it does have a bail.

Kathy used to make her homemade chili for several of our friends when they visited us in our woods on Furnace Mountain. She occasionally used Bee's oven over an open fire to make her chili. The aroma of that pot full of chili filled the air around that big fire. When we took walks in the woods, you could still smell the chili cooking on the open fireplace. She kept bowls sitting on the picnic table and folks took turns dipping her concoction for most of the afternoon. Her chili was always a hit with our friends. (I am ready for her to make some right now!)

We don't really use Bee's Dutch oven anymore, which is why it is located in our storage building. However, I wouldn't sell it for \$500 - it's just too full of memories for me to let go of it.

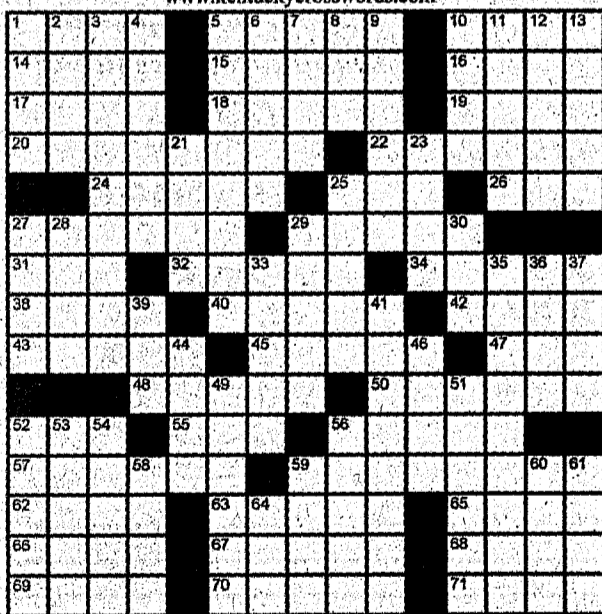

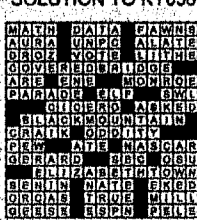

erty. Carloftis said he felt that a separate coordinated effort between the county and Livingston would be better to operate the facility. No action was taken.

The court also discussed a recent action by the court to buy 44 plus acres for use by Livingston in their Trail Town program.

The land, located directly across the bridge in Livingston, was to be sold to the county for \$40,000 by Micah Arnold and was planned to be used by Livingston as a primitive hiking trail for visitors to Trail Town.

Since the original agreement was made, Arnold has asked that .304 acres be carved out of the original 44.396 acres, which contains the house and garage.

McKinney voiced an objection saying the original proposal was sold to the county saying the house and garage were worth \$8-\$10,000 alone. “We’re not doing what we voted to do and I think there ought to be another vote.” County Attorney Billy Reynolds concurred with McKinney and the court voted to allow Carloftis to renegotiate the price for the property, up to \$35,000.

Carloftis gave the county one good bit of news, a reimbursement of \$30,000 of the \$62,000 the court spent on equipment for the Climax Fire Department has been approved by the state from coal severance funds.

McKinney suggested that the court pay the \$30,000 on the \$280,000 loan the court recently took out with KACo for equipment for five other departments in the county. However no action was taken on his suggestion.

The court has also been approved for a \$10,000 reimbursement for money

they spent on the stage at the new Brodhead City Park.

Carloftis told the court that Greer Bros. had finally began paving in the county, starting on Flat Gap Road.

Greer Bros. had given the county several start dates, beginning in early August, but because of their schedule they were not able to begin the project until Monday.

The paving project is being paid for by \$180,000 plus of flex funds from the state.

levels are all aware of these scams. However, he said it is hard for them or other authorities to track down the con artists since they often use fake phone numbers and if they do track them down they are almost always traced to areas outside the country.

According to the Federal Bureau of Investigation, these types of scams are referred to as “advance fee” scams which occur when a victim pays money to someone in anticipation of receiving a prize of greater value, such as automobiles, investments, etc.

Tips that the FBI instructs people to follow for advance fee scams are know who you are dealing with, make sure you fully understand the business agreement that you enter into, be wary of businesses that operate out of post office boxes instead of street addresses and always be wary of business deals that require you to sign nondisclosure agreement or non-circumvention forms.

and repaired cable barriers. Hale said the construction project was completed ahead of time since it was actually scheduled to be completed in December. She said that KTC was pleased with the early

completion of the project despite several delays because of inclement weather.

The lane closures caused heavy traffic congestion on Hwy 25 as motorists were rerouted from I-75. The rerouted traffic also caused a lot of congestion on the city streets in Mt. Vernon and Livingston.

were lucky to get what we got because of the nationwide shortage.”

Carloftis said that salt orders are often prioritized which means that in shortages, state highway departments will usually receive their orders before county highway departments because of the higher volume of traffic on state roadways.

Carloftis went on to say

that motorists’ safety has always been a priority to him and that he has always done everything in his power to keep county roads as safe as they can be in inclement weather.

“Before I became County Judge Executive they didn’t salt county roadways or even have a storage facility to store salt,” Carloftis said. “The rumors saying that we haven’t ordered any salt for this winter is not true and I have no idea where they are getting that from but it’s simply not true.”

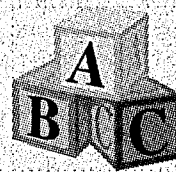

## Hunter shines for EKU in Preseason WNIT

Eastern Kentucky University sophomore, and Mt. Vernon native, Michaela Hunter, knocked down a pair of free throws with 10 seconds remaining in regulation to lift the Eastern Kentucky University women's basketball team past Central Arkansas 56-55 on Friday at Hawkins Arena in the consolation bracket of the Preseason WNIT.

EKU trailed by a point 55-54 following a layup by Central's Terai Sadler with 1:39 showing on the clock; however, sophomore guard Alexis Cooper came up with a crucial steal with 21 seconds remaining and got the ball to Hunter, who was fouled and then calmly sank both free throws to give the Colonels the lead.

Cooper then stole the ball again on UCA's ensuing possession to seal EKU's first win of the 2014-15 season.

EKU's backcourt duo of Hunter and junior guard Shameekia Murray paced the Colonels on the night with 14 and 15 points, respectively.

Hunter also notched team highs in rebounds (six) and steals (four). Two of Hunter's points came just before the first half buzzer to tie the game at 29 all after UCA had led by as many as 10 points in the first half.

In their next game, Hunter recorded a double-double with career highs in points (27) and rebounds (12) during EKU's 69-64 loss to host Mercer on Saturday night at Hawkins Arena in the consolation bracket of the tournament.

EKU trailed by double digits, 57-47 with 6:30 to play in the game, but the Colonels staged a furious rally and tied the Bears 60-60 on a three-pointer by Hunter with 2:17 on the clock.

Mercer stretched its lead back to five, 66-61, before Hunter hit another desperation three pointer -- her fifth of the game -- to make it a one-possession game with 20 ticks showing.

The Bears converted two free throws on their next possession and the Colonels missed their ensuing three-point attempt and the game was over.

Hunter finished 10 of 20 from the field and 5 of 7 from behind the arc. She also collected a team-best 12 boards, dished out three assists, blocked a shot and came up with a steal.

## A Nation Under God

In this great land, we have a cherished tradition that is 393 years old.

This tradition is rooted in an observance of the Pilgrims at Plymouth in 1621 that remembered their Judeo-Christian heritage. After a long and hard winter that reduced their number by almost half, those 53 remaining Pilgrims and 90 friendly Indians "feasted for three days" to thank Almighty God for a good harvest. Edward Winslow wrote of that event, "...by the goodness of God, we are so far from want that we often wish you partakers of our plenty."

Then, 168 years later in 1789, a short time after the original thirteen colonies declared independence and became the United States of America, George Washington, first president of the new nation, issued a proclamation declaring November 26, 1789 to be the first nation-wide Thanksgiving celebration. The day was for a purpose; it was to be set aside "As a day of public thanksgiving and prayer to be observed by acknowledging with grateful hearts the many signal favours of Almighty God."

During the dark days of the Civil War, President Abraham Lincoln, in 1863, issued a proclamation that called for a national day of "Thanksgiving and Praise to our beneficial Father who dwelleth in Heaven" to be celebrated on November 26 of that year. With that proclamation, Thanksgiving became an official holiday in this nation.

As the dark clouds of World War II began to gather, both houses of Congress, on October 6, 1941, passed a joint resolution that established the fourth Thursday in November as Thanksgiving Day. That act gave a grateful nation that had been richly blessed an opportunity to remember those blessings and be thankful to Almighty God, source of them.

Thanksgiving is more than a time for families to get together to enjoy a good meal. It is a special time for them, the strength of the nation, to prayerfully recognize that our beloved land is a nation under God who has blessed it abundantly.

## Janet Wells named Kentucky's Outstanding School Media Librarian

Janet Wells, Librarian at Rockcastle County High School, was named the 2014 Outstanding School Media Librarian at the Kentucky Library Association/Kentucky Association of School Librarians Joint Conference in Louisville.

Wells, currently in her 20th year as Librarian and 30th year as an educator, has served in a variety of leadership roles through her professional organization, Kentucky Association of School Librarians. She recently finished her term as State President, which included planning the Summer Refresher Professional Development Day for

school librarians in July, and also planning the KASL portion of the KLA/KASL Joint Fall Conference in September. The 2014 Summer Refresher set a record for the most attendees with 310 librarians present, while the 2014 Fall Conference featured the first-ever Kentucky Bluegrass Award Author Luncheon. Previously she served as President of the Central District of KASL and also served on various CKASL committees. Wells was named CKASL's Outstanding School Librarian in 2004 and 2014, and also the 2005 Outstanding School Media Librarian for the state.

Among Wells' notable accomplishments in the past year were her state-wide advocacy efforts for school librarians in the midst of budget cuts in several school districts. She also participated in National Library Legislative Day in Washington, DC, to lobby Kentucky's congressional delegation to support national funding for school libraries. She developed a roster of all public and private school librarians in the state to ensure regular contact from the state organization. She attended district library meetings throughout the state and supported librarians facing book challenges. She served as a voting delegate in the Affiliate Assembly of the American Association of School Librarians at meetings at Seattle, Chicago, Hartford, Philadelphia, and Las Vegas. Wells is also a regular presenter of workshops to school districts, KLA conferences, and KASL conferences on

the topics of advocacy and young adult reading.

In June, Wells accepted the ABC-CLIO Leadership Grant of \$1750.00 on behalf of the Kentucky Association of School Librarians at the American Association of School Librarians Awards Program in Las Vegas. KASL's winning proposal includes developing the next generation of school library leaders throughout the state at four area leadership training conferences.

## USDA Farm Service Agency County Committee Elections Began Nov. 3

USDA encourages farmers and ranchers to make their voices heard by voting in the upcoming Farm Service Agency (FSA) County Committee elections. Beginning Nov. 3, 2014, USDA mailed ballots for the 2014 elections to eligible producers across the country. Producers must return ballots to their local FSA offices by the Dec. 1, 2014, deadline to ensure that their vote is counted.

FSA County Committee members provide an important link between the local agricultural community and USDA. Farmers and ranchers elected to county committees help deliver FSA programs at the local level, applying their knowledge and judgment to make decisions on commodity support programs; conservation programs; indemnity and disaster programs; emergency programs and eligibility. County committees operate within official regulations designed to carry out federal laws.

To be an eligible voter, farmers and ranchers must participate or cooperate in an FSA program. A person who is not of legal voting age, but supervises and conducts the farming operations of an entire farm may also be eligible to vote.

Eligible voters who do not receive ballots in the coming week may pick one up at their local USDA Service Center or FSA office. The deadline to submit ballots is Dec. 1, 2014. Ballots returned by mail must be postmarked no later than Dec. 1, 2014. Newly elected committee members and their alternates will take office Jan. 1, 2015.

# The American Revolutionary War Patriots of Rockcastle

By Karen Hamm Adams

To celebrate and honor the county's American Revolutionary War Patriots and to enlighten the community about the service and sacrifice of these brave men, on behalf of the Rockcastle Chapter of the Daughters of the American Revolution, I have compiled highlights of the service of the known patriots living in the county and who applied for a pension between the years of 1818 and 1842. All information was taken from the patriot's own account from his pension application and other historical documents. More information can be found on each patriot at the local library or the Rockcastle Historical Society. (Copyright Pending). **Henry Pumphrey**

Henry Pumphrey was born on 24 December 1754 near the city of Baltimore, Maryland and died 17 October 1834 in Union Co. Indiana. According to his pension application, Henry gave the following account of his service on 26 November 1832 in Rockcastle Co. KY at the age of seventy-

eight. He enlisted in the Army of the United States as a Ranger in Captain Alston's Company in the Regiment commanded by Colonel Blumet in 1778. This enlistment was for eighteen months of service. He served as a Ranger in the neighborhood of Natchez, MS until his term expired. Natchez at that time was part of the Georgia territory. He ranged up the Mississippi River, the Bayou Pierre and Big Black River and down the river occasionally below Natchez.

He was in a great many small engagements with the British and Indians. The British came up the river in schooners and sloops in the night and the next morning, they attacked the town and fort. Pumphrey and his group evacuated the place and went about seven miles below and about two miles from the river and stationed near a widow Winfrey's home. They stayed there for about six weeks. When Captain James Willing from Fort Pitt came down the river with three sloops of men, they returned to the town and retook the fort. They laid siege for several days and at length and were ready to undermine the fort and blow them up when the enemy came out and stacked their arms and were made prison-

ers. On another occasion, Pumphrey was out ranging and scouting and took lodging in an abandoned house where the family had moved into the fort at Natchez. There were fourteen men in Henry's group and in the night while they were asleep, the enemy fired in and killed eleven men in the company and took all the horses. Henry was later discharged at Natchez by Colonel Blumet some time before the surrender of Lord Cornwallis.

On his return trip home to Maryland from Natchez, Henry was in the company of four men: Colby Rucker, John Henderson, Philip Hays and Willis Cotton. They were taken prisoner on the Oconee River in the state of Georgia by Captain Ingram, a Tory. They were then taken to Savannah, GA and placed in the possession of General Campbell, a British officer, and his discharge papers were taken from him. Henry was a prisoner of war for four months and five days when he got away from the enemy and went to General "Mad Anthony" Wayne's camp at Ebenezer, GA. According to Colby Rucker's pension application, he and Henry were able to escape by obtaining two nightgowns and they

fashioned women's dresses for them. Disguised as women, they made their escape by simply walking out of the prison compound.

From there, Henry went to Wilkes Co. North Carolina and was again called into service. He hired a man by the name of John Hall to go in his place as a substitute and this man served out a tour of six months and was in the Battle of Eutaw Springs. Henry volunteered to serve three months under Captain Joseph McDowell and Colonel Joseph Hern to fight the Indians. He marched to the Cherokee Nation and killed a great many Indians, burnt their huts and corn and took prisoners.

Since the time of his enlistment, he resided in North Carolina about forty years. Since that time he lived in Indiana and Kentucky. Henry married Lucy Shepherd on 24th December 1783 in Wilkes Co. NC. To this marriage at least ten known children were born. About 1814, the Pumphreys left North Carolina and settled in Rockcastle Co. KY by 1815.

Henry was allowed a pension, executed 26 November 1832 in the amount of eighty dollars annually for his service as a private. He died 17 October 1834 in Union Co. IN at the home of his son-in-law,

Reuben Bullock. His wife, Lucy applied and received a widow's pension on 2 April 1839 in Pulaski Co. KY. She died 31 December 1844 or 1845 in Garrard Co. KY. Their final resting place is unknown.

The known children of Henry and Lucy are: Larkin Pumphrey (1785NC-About 1832 Fayette Co. IN) married Frances Shepherd in 1806 Wilkes Co. NC. They had eight children: Eli, Martha, John, Delpha, Jackson, Sarah, Joseph and Andrew. John Pumphrey (October 1786 Wilkes Co. NC-1831N) married Elizabeth Ann Shepherd (1790-1830) on 26 June 1807 Wilkes Co. NC. They had seven children: Alfred, John, William, Lucinda, Larkin, Eliza and Andrew. Sally Pumphrey (1789 Wilkes Co. NC) married an unknown Thompson. Elijah Pumphrey (11 January 1790 NC-1875 Missouri) married Lucy Mastin (1792-1813) in 1812 and married Olivia Wilson (1796-1882) in 1816. Children of Elijah are: William, Lucy, Mary Ann, Jonas, Nancy, Bird, Sarah, Joshua, Rebecca, George and James. He is buried in the old Confederate Cemetery in Platte Co. MO. Lewis Pumphrey (July 1792NC-1855AR) married Polly Thompson and

Eliza Reed. Children of Lewis and Polly were: Meredith, Nancy, William, Benjamin, Elizabeth and Matilda. Children with Eliza were: Richard, Perusha, Jerusha, Lewis and John. Delpha Pumphrey (May 1795NC). Andrew Pumphrey (February 1798 NC-1 October 1876IN) married Mary E. Lawrence in 1820. Andrew is buried at the Old Pumphrey Cemetery in Decatur Co. IN. Andrew and Mary had thirteen children: George, Permettia, Armistead, John, William, Andrew, May, Cyrus, Francis, Jasper, Martha, Eliza and unknown infant. Lucy Pumphrey (September 1801 NC): Elizabeth Pumphrey (July 1804 NC-About 1850 KY) married Reuben Bullock (1809-1861 Pulaski Co. KY) on 24 November 1828 Rockcastle Co. KY. They had at least five children: Amanda, Gray, Zemary, Elizabeth and McHenry. McHenry Pumphrey (1810 NC-8 November 1880 IL) married Charlotte Knight (1819-1880) on 7 August 1855 IL. They had at least three children: Eli, James and George.

Henry Pumphrey is a recognized Patriot of the Daughters of the American Revolution.

The KHSAA preseason rankings have the Rockets ranked last in the 47th district with Pulaski County ranked first, Casey County second and Somerset third.

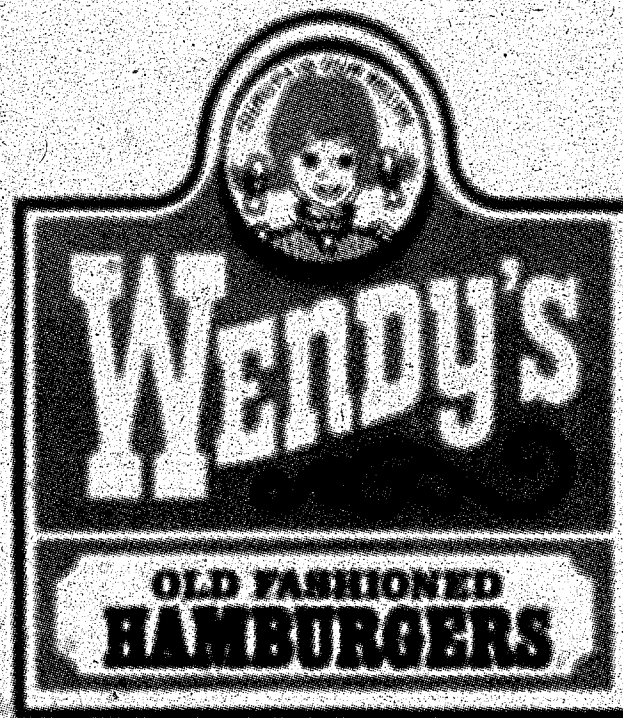
