

Magistrate Asks to See List of **Those Receiving Food and Fuel Vouchers from County**

A list of the names of the people that had received vouchers or letters from the Fiscal in order to obtain groceries, coal or oll was asked for but not received by Magistrate Frank Deborde at the Rockcastle Co. Fiscal Court's regular monthly meeting Tuesday morning. Mr. Deborde said that he was not against anyone receiving aid that really needed it, but he said that he was against these funds being provided for personal or spolltical gain.



Well, on several lakes a-round Kentucky there are such signs, and more are going up all the time. The signs, pictures of a signs, and note are going up an inte time. The signs picture, indi-cate where man-made fish at-tractors have been stabilished Currently, the Kentucky De-partment of Fish and Wildlife Resources, the U.S. Army Corps of Engineers and the Tennessee Valley Autority are engaged in attractor programs. Most attractors are made from brush piles anchored to the bottom. Brush is easily ob-tained and seems to attract fish better than 'artificial' objects such as old tires or concrete blocks.

block

With the crapple spawning season upon us, anglers should find these attractors particular-ly productive since they ought to form natural magnets for spawning crapple. However, studies have shown that almost all fish-everything from bass to catfish-use attractor sites.dur-ing much of the year. Most of the attractors estab-lished by the Fish and Wildlife Department cover about an acre of lake bottom and are marked at each corner by a bouy with the fish attractor symbol sten-ciled on it. "A lot of fishermen think they have to park their boat right next to a bouy to be over productive water," says Bill McLemore, the biologist in charge of the attractor program for Western Kentucky. Actual-ly, McLemore says, there might not be any brush right beside the.bouy, since these markers-only serve to show the outer only serve to show the outer



Nearly \$7 Million Bonus On '75-'76 Burley Crops

By Bennett Roach

Nearly \$7 million in "bon-us" payments will be distribu-ted to farmer-members of the Burley Tobacco Growers Coop-erative Association early in June. The distribution represents net gains earned on 1975 and 1976 crop tobacco which has been held under loan. Checks will be issued to

1976 crop tobacco which has been held under loan. Checks will be issued to growers who pooled aportion of their crop in either of those two years. The 1975 crop earned \$2,382,820.72 clear of expenses, and the 1976 crop netted \$2,518, 132.87, on burley consigned to the Growers Association under price supports. These payments are in add-ition to advance money received by growers at the time of sale. Only those farmers with pool consignments out of their 75 and 76 crops will share in the current distribution. Approximately 150,000 checks are being prepared at the Burley Association headquar-ters, 620 South Broadway, Lex-ington, Ky., for the June mail-ing. As there were large burley

ing

ing. As there were large burley crops marketed in '75 and '76 the checks will reach growers in every tobacco county in Ken-tucky, Indiana, Ohio, West Vir-ginia and Missouri-the states in which price supports are hand. which price supports are hand-led by the Burley Association.

When the disbursement pro-cess is completed the total returns to growers will be in excess of \$23 million over the 40-year operation of price sup-

Last year the Association returned \$390,180.74 to grow-ers on the 1974 crop, and in 1976 about \$11 million was distributed as earnings on the '69, '70

ted as earnings on the '69, '70 and '72 crops. Distribution payments on tobacco under loan are made after an entire year's holdings are sold by the Association. Net gains depend upon price received, costs of storage, insurance, processing, trans-

Beckley, executive secretary-treasurer of the As-sociation, said the '75 and '76 crops earned \$11,143,684.87 in interest, for C.C.C. Also, the growers' carmings on those crops included \$522,785.77 inter-est, which is included in the which is included in the distribution

distribution. All of the loan stocks of tobaccoheld by the Association have been sold, but 24 million pounds remains on hand under deferred sales contracts. Settle-ments on these await final close-outs, after interest, storage and other costs, and final approval by Commodity Credit Corpora-tion.
