



## Nearly 10,000 'pot' plants found, burned in Rockcastle

Once upon a time tobacco was Rockcastle County's number one cash crop. That was quite awhile ago.

That was quite awhile ago. For the past several years mari-juana has been the number one reve-nue crop in Rockcastle County. But last week state police and forest serv-ice made a big dent in this year's gross revenues from the sale of the illegal weed, seizing nearly 10,000 plants

plants. On Thursday police located 34 plots of marijuana in the Sand Hill area of the county. With the help of a state police helicopter 30 officers

moved in and destroyed 4,733 plants. The marijuana was valued at around \$5 million. The efforts of the state police are

### Dove, Duck Season

Dates for the 1988 dove season are Sept. 1 - Oct. 12 and Nov. 24 - Dec. 11. The dove season is 10 days shorter than last year, but the daily bag limit has been raised to 15 and the possession limit to 30. East season, daily bag and possession limits use possession limit to 30. Last season, daily bag and possession limits were 12 and 24, respectively. The reason for the shorter season

and increased daily limit is that to-ward the end of the first part of the ward the end of the tirst part of the season, many doves have already migrated south and hunting opportu-nities in Kentucky decline greatly. Allowing hunters to bag more birds during the early part of the season provides more hunting opportunity when greater numbers of doves are available.

The early duck season will be September 7-11 his year. However, due to poor nesting conditions, he worst on record in Canada, only wood ducks may be taken during this season. Kentucky is one of only three states in the lower 48 to have a Sep-tember duck season in 1988. The daily bag limit will be two wood ducks, or one wood duck and one duck of another species, except state and federal wildlife laws. 


