## At Mt. Vernon's regular monthly meeting Council votes to obtain funding for tourism project, buys fire truck, raises water rates


**By: Richard Anderkin** At Monday night's regular monthly meeting of the Mt. Vernon City Council a massive amount of business was conducted, with an even larger amount of money being spent. In a nutshell, the council voted to give Mt. Vernon Mayor Clarice Kirby the authority to obtain funding for the Rockcastle Tourism Commis-

sion and funding for the balance due on the purchase of additional property for the city park on Williams Street.

The council also voted to buy a new fire truck and a new

backhoe and they raised water rates. After Monday's meeting,

Mayor Kirby now has the authority to obtain funding in the amount of \$750,000 for the

## **Community Trust Bank will loan county funds for SoureCorp Building**

By a unanimous vote last Thursday, the Rockcastle Fiscal Court approved an ordinance for financing of the \$2.7 million construction costs of the new SourceCorp building with Community Trust Bank. would become a general obligation debt of the county or leasing the money from Community Trust Bank.

Ross, Sinclaire, a Lexington based bonding company which specializes in public financing, had told Carloftis and Magistrate Bill McKinney that the bond market had tightened considerably since the first time an issue was discussed and the projected interest rate would be 7%, and perhaps 8% or higher on the day of issue.

Also, fees to Ross, Sinclaire for handling the process would amount to about \$60,000, McKinney said.

On the other hand, the interest on a loan from Community Trust Bank, according to Mike Blount, Market President for Rockcastle County. would range from 4% to 7 1/2%. The terms are actually 1/2% above prime, however, the floor is 4%.

Community Trust offer would be the best for the court because the prime would have to rise considerably before it would affect the county's interest rate. Clontz also said the lower interest rate would save the county as much as \$150,000 over a three year period. Rockcastle Tourism Commission, which will purchase 20-23 acres overlooking, Renfro Valley, I-75 and Lake Linville, where they plan to build a tourism conference center in the likeness of a castle.

The \$750,000 will come from the sell of low interest bonds through the Kentucky Area Development District's (KADD) Financing Trust.

Mayor Kirby again told the council and those present, including members of the tourism commission, that the loan would be paid back by the tourism commission through the city. The Mayor said the City and Tourism Commission would have a detailed contract as to the pay back obligation.

Tourism CEO Susan Laws said at an earlier meeting of the council, that some of the proceeds from the 3% restaurant tax would be used to pay off the loan.

Laws said the restaurant tax generates anywhere from \$20,000 to \$30,000 a month, which is split between the city and tourism commission.

The Tourism Commission had requested the money be borrowed by the city because the Tourism Commission does not qualify for low interest loans, such as the one being obtained.

The Mayor did not give the council any details as to the length of the loan but she did say the interest rate would be around 5%.

Before the council voted on the funding, local resident

Mike Smith questioned the Mayor and Laws as to the feasibility of the project.

Smith said he thought the purchase price was extremely high and was a bad idea, given the current state of the economy. Smith said he was afraid that local taxpayers would end up paying for the tourism project because it could not pay for itself and that if the land had to be sold to pay off the debt, it "wouldn't bring what you all are paying for it."

Laws told Smith that extensive research had been done on the project and that she did not think Congressman Harold Rogers would be supporting the project, if he and his staff did not think it was feasible.

The discussion between the Mayor and Smith, who also





Pop was a School Board member A few weeks ago I was fortunate enough to be elected to the Powell County Board of Education. For most of my life I have been involved in education, and I look forward for this opportunity to serve during this difficult time.

When I was a small boy, my grandfather Eugene Stokes (Pop) was also a school board member in Rockcastle County. He too was very proud to serve. Pop thought that education is the most important aspect of a child's development – even though he did not have a high school diploma himself.

Pop was a businessman, and he worked harder than anyone I ever knew. During the week, he traveled across several counties selling Aubry Red "A" feed and groceries from Louisville Grocery Company. When he first began this vocation, his travels were on horseback. Rain or shine he rode that horse to the businesses in his district.

I never heard him complain about how hard he had to work. He was proud to have a good job in those challenging times. Later he wore out several automobiles with his travels as a "drummer of goods."

Such a business was not without its dangers. One dark and stormy night (yes, really), Pop was headed home during a severe thunderstorm when a bolt of lightening hit his horse, knocking it to its knees. I remember him describing it by saying, "I thought a tree had fallen on my head." After he was able to get the horse back on its feet, he led the animal for several miles back home.

When he was elected to the board position, Pop served with several other important men from Mt. Vernon. He was

proud of his position on the Mt. Vernon Independent Board of Education. Pop was extremely pleased to be serving with such successful gentlemen.

Mr. Logan Bryant was one of Pop's close friends, and they served on the board at the same time. Mr. Bryant owned and operated Bryant's Appliance Store on Main Street. I first got to know him when Pop took me to the store and asked if his grandson could purchase a stereo record player on time payments.

Pop assured him that if his grandson failed to make a payment, he would pay off the debt. I saved my money each week and went in every Saturday to pay Mr. Bryant \$2 until the contract was fulfilled. I will never forget the trust both men had in me, and I never missed a payment.

In addition to Mr. Bryant, Doctor John D. Henderson was also a member of the board. His reputation was known all over that part of the state for his ability to make a set of dentures for \$100. People came from far and wide to sit in his office overnight to get first in line. Dr. Henderson would pull the teeth and put in the dentures at the same time.

Two other members of the board worked at the Bank of Mt. Vernon. N.M. Smock was President of the bank. His reputation for honesty and having a good business sense was known throughout the county.

Bob McKenzie was also employed at the Bank of Mt. Vernon as a teller. He too had a reputation for integrity and fair business dealings.

I think Pop loved being in the company of such good and honest men. He treasured their

Sibling unity has been a trademark of the Bakers of Leslie County for nearly seven decades.

In fact, you might say it runs in the family.

Half the clan of 12 was in Renfro Valley on a recent snowy Saturday morning, taking part in a four-mile race sponsored by the hospital in Rockcastle County.

Mollie, 66, was the top runner in her age group on this particular day, pausing to cheer on her brother and sisters after crossing the finish line.

What started 15 years ago with an invitation from one sibling to take part in a race sponsored by her company has turned into a family tradition.

Although all 12 have yet to compete together in a single race, nearly all have taken part at one time or another in half marathons and races of various other distances

At least half come together for marathons in Indianapolis each May and October. A family favorite is the Run For Your Life walk/run held in Hyden each spring to benefit the American Cancer Society.

"We've always been close

## as a family, and the races give us an opportunity to come to-

gether several times a year," said Mollie, a retired English teacher at Leslie County High School.

'We do this, and then we go out and eat," said Evia Mullins, a retired factory worker now living in Mt. Vernon.

The family's togetherness is easily traceable back to their days growing up "along the second fork at Wooten," deep in the hills of Leslie.

Following their most recent outing, all six sat around a table sharing stories and reflecting on childhood days spent with strict, but loving, parents.

Some have vivid memories of their hard-working father making the daily six-mile trip to the coal mines where he put in 12-hour days. The family had a car, but Bill Baker left it in the driveway in case his wife needed it for an emergency

His children recall him coming home often with 50 pound bags of feed on his back for the milk cow, hogs, and chickens raised by the family.

In winter months, their father's wet overalls would be frozen stiff and left standing

My Dad was a coal miner who spent most of his adult life gouging out a living by getting coal from deep inside a mountain to the outside where it could be loaded and shipped to parts unknown, turned into electricity and make the lights glow all over our country.

Most of his time underground was spent on his knees with a shovel or crawling around doing the myriad maintenance chores required to keep a mine going. Imagine yourself in a tunnel only 43 inches high and you are 74 inches tall and perhaps you get some idea of his work environment. Imagine no lights in said tunnel except for the flame from a carbide lamp attached to a helmet on top of your head.

Dad worked, for many years, as part of a four man team that kept a little coal mine going there in the head of Blair Branch in Letcher County where they managed to get 30 or so tons of coal per day from way inside the earth to the light of day.

Dad and his coworkers, all of whom were like family, accomplished this feat by drilling auger holes ten or so feet into the seam of coal, tamping them with dynamite, and blasting the mineral loose, whereupon it was loaded into two-ton gondolas and pulled by ponies to the surface.

Because he spent so much time on his knees, Dad wore heavy, steel-toed boots and "miner's socks" made of thick heavy cotton that came all the way to his knees. The toes wore out really fast and Mom spent at least one evening a week "darning" Dad's socks but that is another story.

Come Christmas, Dad got new socks that Mom would order from Spiegel's, Montgomery Ward, or Sear's and Roebuck. She'd pick out a couple of pairs on Christmas Eve and give one sock each to my three younger brothers and me and help us write our names on top of the sock.

We'd make a big deal out of it, Keeter and me, by fastening our particular sock to the fireplace mantel with a heavy nail and nail holes were already for that express purpose. Andy and Steve were too young to be interested in volume, but Keith and I were sold on the notion that the more a "stocking" held, the heavier it was apt to be, and we wanted it full and in no danger of falling into the fire.

Which is why we were only allowed to hang them on Christmas Eve. A stray spark into one of Dad's big long socks would have set the house afire. I'm reasonably sure that My Mom watched her boys go to sleep on many a Christmas Eve and then set up all night to make sure that didn't happen.

For some children, however, the virus can be very serious. These are usually children who are between the ages of two and five months. They are old enough that they have lost the immunity they received from their mothers and too young to toler-



ate such a harsh virus. Children who have lung, heart or immune problems are also at greater risk of complications from RSV. One of the other problems with this virus is that it may take two or three infections before a child develops good immunity to it.

The virus is spread by coughing and close contact, such as touching hands. The virus is so common that most children have had the infection by three years of age. After this age, RSV infections are seldom a problem.

The virus causes a great deal of irritation to the lining of the lungs. Increased mucus and sloughed cells cause the tiny airways to plug up. This plugging slows the air that is leaving the lungs, so the lungs become over-expanded in a way similar to emphysema. In the more severe cases, the airways become completely plugged up and the airways collapse.

Treatment is usually aimed at reducing the symptoms and making sure a child is getting adequate oxygen. Infants often need to be hospitalized for RSV infections. A steroid syrup or shot is commonly used and can decrease the symptoms. In severe cases, an antiviral antibiotic can be used, but its usefulness is still being studied.s good to keep stresses to a minimum.

Suffice to say that the stocking were, indeed, hung by the chimney with care.

By the time I was 10 or so, the Santa Clause ruse had been long shot down. Keeter and I had been cajoled into playing along for the benefit of everskeptical, little bros, Andy and Steve.

Presents from each to another got wrapped and placed under the tree a week before Christmas because that was about as long as we expected a tree to last without being a time bomb that might explode if a spark got to its nettles . But until I was in college, the Adams Boys expected to have those "stockings" filled with something even if we had to pretend sleep while Mom and Dad did the stuffing.

When I was an adolescent, we usually got many rolls of "caps" for our toy cowboy guns---black powder that would explode inside our guns with a loud bang and fed into the cylinder as fast as we could pull the trigger and even firecrackers that we turned into small sticks of dynamite. As we

got older, we received BB's and even shotgun and .22 rifle shells. Stuff that would make modern parents shudder in disbelief. I was a freshman in high school when I got up one morning to discover a bottle of Old Spice after shave in my stocking and decided that Mom was now calling me a man.

In retrospect, that simple gift was probably the most important acknowledgement of my coming of age that I experienced in those heady years of the early sixties.

But always, always, we got the "cream of the crop" apples and citrus fruits and nuts inside our stockings and little squares or wedges of fudge laced with black walnut kernels my Mom had made while we were at school, and Dad's new socks were all stretched out to the breaking point and smelling better than they ever would again.

But he wore them and wore them out, there on his knees in that old mine. I simply hope that when they are my age, my kids will remember what it we used to do for them at Christmas the way that I'm remembering mine just now.

Dear Editor,

Kentucky Citizens for Open and Responsible Public Services, LLC is a non-profit limited liability company. Its acronvm is KYCORPS. Membership in KYCORPS is free and open to anyone. The KYCORPS web site (www.kycorps.org) will be activated by mid-January 2009 to facilitate membership applications, dissemination of information, and open discussion of issues.

With the enactment of the open meetings laws (KRS 61.805 to 61.850 and 61.991) in 1974, our Kentucky General Assembly asserted that the business of the public should not be done in secret. All of those who have served as Kentucky Attorney General since the passage of these laws and our Courts have vigorously decided in favor of citizens who sought to attend meetings, but who were first denied. Still there are both elected and appointed officials who don't agree with these laws. They prefer the convenience of backroom politics over openness and believe that the power of their positions can be used however they choose.

our open meetings laws rest, and they know that their organizations are more successful when these laws are strictly followed.

Also there are impeccably professional organizations devoted to creating openness and public involvement. Examples include the Kentucky Rural Water Association and the Kentucky Public Service Commission. These two co-sponsor annual training for water boards that includes: "Ethics" and "Open Records and Open Meetings." KYCORPS applauds these activities. Unfortunately there is a dearth of similar training for users who need to know their rights and for citizens who wish to become board members. This is a need that KYCORPS will help meet by providing both webbased and in-person training.

Dear Editor.

You claim my 11/27 letter's reference to "\$36,000 for fireworks" is one of "several figures" that are "incorrect" since, according to you, I "say[s] the city is paying \$36,000 for fireworks.

Now you claim this, but the truth is that nowhere in my letter did I "say[s] the city is paying for \$36,000 for fireworks." It's just not there.

In fact the only reference I

money for non-governmental functions. This includes responsibility for the \$12,000 from the tourism board who has been assigned the task of spending tax dollars on events like this. The tourism board is primarily funded through the city's \$250,000 yearly restaurant tax (74.2% of its \$337,500 budgeted non-rollover revenue). Although, through a complex arrangement, half of the restaurant tax is sent back to the city for "city beautification" (\$77,600 since April) and other items (\$42,700).

Particularly noteworthy of the local officials who approved this was the absence of important questions about this event. How many people have attended similar events in equally sized cities? How many people will attend from the county? From neighboring counties? From out of state? How much will an average visitor from each of these spend on rooms? Food? Gas? How much of the money spent at McDonald's or Shell is actually kept in the county? How much more of our money are they willing to redistribute to encourage low income, dead end jobs at fast food restaurants and gas stations?

Equally noteworthy is the destruction of prior private economic activity at the boat dock VFW fireworks show.

I'm happy to write about the budgetary details and issues of the \$36,000 fireworks show which taxpayer's are paying for.

But between the amounts spent on the castle, the Cox law building, the fireworks, the sidewalk to nowhere, the straw, pumpkins, gourds and squash, on all day lights, and various overpriced properties, every detail can't all be fit into every letter.

I did not "say[s] the city is paying \$36,000 for fireworks." I deserve a retraction of your claim.

straight up on the porch, recalls Eldon, 66. "He had it rough, but I don't think any one of us ever heard him complain," says Helen Joseph of Leslie County.

Alice Stidham, a tax accountant in Franklin, Indiana, recalls her dad kissing his children goodbye before leaving for work and kissing them all good night each evening.

"It was a wonderful life," says Brenda Martin, an underwriter in Indianapolis. We were like the Waltons, only without the big house.

Evia recalls a family rule that required everyone to come to the kitchen table at the same time and stay until the last person was finished.

"He would always say 'Go wash up and come and eat," recalls Alice.

Several giggled at the memory of their father having them line up and introduce themselves when strangers would visit.

After the family got their first TV in the early 1960's, Evia remembers being allowed to stay up and watch Gunsmoke with her Dad. "He liked to see if we could outdraw Matt Dillon. Then he'd tell us to go on to bed so we could all be in church the next morning."



## **Poplar Grove Baptist dates back to 1869**

Poplar Grove Baptist Church was organized as Brush Creek Church in an old house on the hill, northwest of Bull Pen Branch near Level Green on the last Sunday of August, 1869.

In 1873, the church was moved to its present location on Richland Road and named Poplar Grove Baptist Church.

Early church records before 1900 are very meager. Early records show Baptist being spelled "Babtist." Early church records were possibly recorded by James Hurst, Joe Hasty, Logan Ping and John Thomas Hurst.

Business meetings of the early church were held on Saturdays. At the beginning of these meetings a request was

made for the report of the harmony in the community. In some revival meetings there are records of as many as 35 being saved. We thank God for these blessings and are thankful that He is still blessing in the church today

In the early history of the church, the Communion Service time was voted on and was usually held once a year. The early revivals were called "protracted meeings" and usually lasted 12 to 14 days with both day and night services. Bro. Ruben Hurly was granted a license to preach the Gospel at the February, 1906 business meeting. The first listed treasurer, Bro. William Hurst, was elected in December 1907. In some parts of history, the treasurer was referred to as a colsometimes lector or "treasurerman."

The first mention of the executive board was in March 1908. From early records to present, the church had always voted to send members to represent the church at Associational Meetings. In 1899 the Associational Meeting was held at Poplar Grove with J.C. Carmackle as moderator, W.H. Sowder as clerk, and D.S. Devault as the minister preaching the sermon.

In 1913 the Associational Meeting was also held at Poplar Grove with A.J. Pike as moderator, J.J. Painter as clerk, and T.C. Duke as the minister preaching the sermon.

Bro. N.T. Gibbons was ordained to preach in February, 1917.

In 1921 the Associational Meeting was again held at the church with L.D. Gooch as Moderator, J.J. Painter as clerk, and J.G. Bow as the minister preaching.

In December 1925 the first paid sexton for the church was hired for \$1 per month. In modern day, this office is known as janitor. In January 1926 the church voted to pay the pastor \$14 a trip Remember most pastors were "circuit rider preachers." A specail collection for missions was received in July of 1926. The amount was \$5.10.

In September of 1926 the Rockcastle Baptist Association







suggested that the churches send aid to the orphans' home. After consulting with each other, the sisters agreed to send some chickens to Glendale and some fruit to Lovisville. The brethren agreed to pay the freight on it.

The first listed Sunday School Superintendent was A.F. Lawrence in December 1935. At this meeting, the deacons decided to vist members and learn from each one what they cared to do towards helping in church work and services in the coming year of 1936.


An additional 1 acre of land for the cemetery was received from H.N.Denney and wife in May of 1936. On August 4th and 5th, 1936, the Associa-

tional Meetings were held at Poplar Grove with E.K. Cook as Moderator, Roy Sayers as clerk, and J.A. Bass at the minister who preached.

E.K. Cook served the church as clerk for many years and his wife Mrytle (Farley) Cook served as treasurer. The first mentioned cemetery committee consisted of Rev. N.T. Gibbons, Virgil Brown, and A.F. Lawrence in October 1936.

In March 1937, a committee, consisting of Julia Hurst, Cles Hurst and Myrtle Cook was formed to solicit money to buy songbooks. Ten gallons of white paint was purchasd in April 1937 to paint the building. It was bought for \$20. In September 1939 a committee was formed to see if people in the church and community would donate material and labor to fence the cemetery.

In April 1941, the church

voted to have Vacation Bible School in June. The offering received during the school was \$4.80. On Mother's Day, May 1941, an offering of \$5.83 was recived for the Baptist Hospital. Bro. James McKinney was elected caretaker of the cemetery for \$80 for 1 year in May, 1942.

Bro. Stevens from Hazard came to the church in April, 1945 on Monday through Friday nights to speak on Stewardship. On the second Sunday in July of 1945, Bro. Grubbs, and Bro. Philbeck helped conduct an All Day Meeting, emphasizing missions.

In November 1945, the church received the Thanksgiving Offering for the Orphans' Home. The amount received was \$15.94. The church agreed to contribute to Home Missions in July, 1948. A building fund was first mentioned as being organized in December, 1949. Also a visiting committee was also organized at this time. The Associational Meeting was held in 1951 at Poplar Grove with C.H. Philbeck as Moderator, E.R. Denney as clerk, and Paul Payne delivering the message.

In May 1955 the church voted to have prayer meeting on each Wednesday Night. In September 1955, the church voted to put a basement under the church and arrange for heating. A Men's Brotherhood was organized in Junuary, 1958. Bro. Floyd Bingham was ordained to the Gospel Ministry on May 17th, 1959. In July 1962, it was discussed about the upcoming County Wide Revival. In August 1962, a World Missions Conference was discussed. In September 1966 the church decided to purchase a new pulpit and seats.

On Sunday, A ugust 31, 1969 a Special Centennial Service was held by the church to commemorate its 100th Anniversary. Bro. Don Cummins was pastor at this time. The 1969 Associatinal Meeting was held at Poplar Grove with John Zupancic as Moderator, G.W. Coldiron as clerk, and J. Chrisman delivering the message. Most of the pastors were elected yearly until 1969 when they began being elected in-

On November 11, 1970 the church voted to give 10% of each month's income to missions. In October 1971, a World Missions Conference was held. On October 17th, livering the sermon. The 1973 Associational Meeting at the church was led by Mike Bryant as Moderator, G.W. Coldiron as clerk, and Gene Noe delivering the sermon. On April 21, 1974, the church received a freewill offering to help restore Pleasant Run Baptist Church after it was destroyed by a tornado. In December 1975 the church voted to begin Training Union. On November 16, 1977 the congregation adopted a Constitution and By-Laws for the church. In April 1978, a 20 foot addition was added to the present church building. During this building project two Sunday School rooms, a Baptistry and two restrooms were constructed. The church also was bricked. The present plaque in the foyer was installed at that time.

In April 1979 the church voted to help pay the expenses for the Ten Commandments to be placed in each classroom in the Rockcastle County School System and every office in the Courthouse. This was done as a joint project with other churches.

The first person to be beptized in the new baptistry was Junior Reynolds on October 21, 1979. In 1980 Poplar Grove hosted the Associational Meeting with Lester Caldwell as Moderator, C. Bradley as clerk, and John Zupancic delivering the sermon.

Bro. Shelby Reynolds surrendered to the Gospel Ministry on May 15th, 1983. He was ordained on August 28th, 1983.

In December 1983 the church voted to remodel the basement, adding cabinets and a sink. Prior to this time a Sunday School room partition had been removed to form the

W.M.U. In May 1990, a vestibule area, ramp and a porch extension was constructed. In August 1990, the auditorium and foyer area were carpeted and, the next year, a new heating and cooling system was installed.

In March 1994 the church voted to celebrate the 125th Anniversary of the Church on Sunday, September 18th, 1994.

Part of the above history was also printed in the 125th Anniversay Homecoming Book published in 1994.

The following church history had been compiled to complete the church History to the present time.

In December 1994, the first ever Outdoor Live Nativity Scene was presented for the community. Also in this meeting the church licensed Eric Reynolds to the Gospel Ministry. Also, in March 1995 a Family Ministry Conference for the Rockcastle Baptist Association was held at Poplar Grove with Bro. John Lepper from the Kentucky Baptist Convention leading the conference

On October 3, 1995, Hazel Harvey, a well-known Christian actor, came and portrayed "Fannye Crosby" for the Rockcastle Baptist Associational W.M.U. Quarterly Meeting here at Poplar Grove. Also in October of 1995, Poplar Grove was host to the Associational Meeting with Ronald Sears as Moderator, Faith Payne as clerk, and Wayne Henson delivering the sermon.

On Sunday Morning May 5th, 1996 the church hosted a special service for the "Senior Adults" who were 70 and up. The service was well attended with a dinner following. Nine people were given special recogniton. Eric Reynold was ordained to the Gospel Ministry on Sunday afternoon, July 7th, 1996.

During the April, 1997 business meeting, the church voted to set aside Roy Adams and Barry Hurst to be ordained as deacons. They were ordained on Sunday afternoon,

building of the new Associational Offices located on Highway 150 near Mt. Vernon. On December 13th, 1998 the church had a special singing service and also the dedication of all new hymnbooks purchased for the church by Kathleen Brock in memory of her late husband, Ted Brock and parents, Virgil and Ollie Denney all members of the church.

The 130th Anniversary Homecoming was held on Sunday, September 19th, 1999. On April 7th, 1999 the church voted to build a new picnic shelter. During Associational Missions Emphasis Week in May 1999, Bro. Jack Bruce, our present Associational Missionary, preached at Poplar Grove and encouraged us to higher heights in Missions. During the August 1999 Business Meeting the church voted to purchase a copy of "The Ten Commandments" to be posted in the church. Poplar Grove can be acknowledged as having supported mission work locally, in the United Stated, and in the foreign fields. They have also paid expenses for their pastors to attend the Kentucky Baptist Convention and also the Southern Baptist Convention.

God Blessed Poplar Grove Baptist Church with many faithful servants of the Lord. The first ministers of the early Church were "circuit rider preachers" meaning tht they pastored more than one church at a time and sometimes traveled a great distance, usually by horse or by walking to the respective church. Most of them spent the night or nights with different families of the church.

Some of the pastors of the church in the past 135 years include: James M. Cummins, W.F. Meece, A.J. Pike, J.M. Cummins, W.W. Brock, W.M.C. Hutchins, D.B. Wyrick, W.G. Colson, Clyde Gooch, N.T. Gibbons, Eugene Bradley, George Fletcher, John G. Presley, Marvin Combest, R. Brown Hughes, John Killinger, C.W. Burkhart, J.L. Dennington, W.W. Kelley, R. L. Singleton, Lewis Jones, Don Cummins, Linville Coldiron, Sherman Adams, Harold Harris, Howard Mounce, (interim pastor), Gary New, and Jack Bruce,.







In general, the best way to help those who are grieving during the holidays is to let them know you care. They need to be remembered, and they need to know their loved ones are remembered, too. Invite the person to attend a religious service with you and your family.

Invite your friend to your home for the holidays.

Inquire if your friend is interested in volunteering with you during the holiday season. Doing something for someone else, such as helping at a soup kitchen or working with children, may help him or her feel better about the holidays.

Make a donation in memory of your friend's loved one, as a reminder that his or her special person is not forgotten. Remember to avoid telling your friend that he or she should be "over it;" grief is an individual process and there are no right or wrong ways to grieve.

If your friend wants to talk about the deceased loved one or feelings associated with the loss, LISTEN. Don't worry about being conversational.... just listen.

Remind the person you are thinking of him or her and the loved one who died. Cards, phone calls and visits are great ways to stay in touch.


On Saturday afternoon the Lady Rockets beat a good Henry Clay team in the Defender Classic, 56-47.

On Thursday night the Rockets easily defeated Lynn Camp on the road, 84-61.


The Rockets jumped out to an 18 point first quarter lead and never looked back.

10 Rockets got into the scoring column with Spencer Mullins leading the way with 27.













## Rockcastle gets funds for ( emergency food and shelter

Congressman Harold "Hal" Rogers (KY-05) announced today the release of \$448,436 in combined funding to counties throughout the Fifth Congressional District for the Emergency Food and Shelter National Board Program (EFS). Rockcastle's share of the funds is \$12,366.

The EFS program, administered by the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA), supplements and expands ongoing community efforts to provide shelter, food and supportive services to the nation's hungry, homeless, and people in economic crisis.

"The Christmas season is often a time of gift-giving and abundance, but many in our community are simply struggling to put food on the table, make a mortgage payment, or cover heating costs this winter," stated Rogers. "This federal infusion of funds into our communities will result in families staying together

through the holidays or a veteran making it to a doctor's appointment for medication. This Christmas, we must not forget our many blessings and continue to extend a helping hand to those around us. I am pleased to see FEMA get these funds to our communities before the New Year."

FEMA, through the Emergency Food and Shelter Program, allocates funds nationwide to the neediest areas and ensures fast, targeted response through public-private partnerships. Funds can be used for food, lodging, transportation, rent and utility assistance, and minimal community center facility repairs. Nationwide, \$200 million has been awarded to over 2,500 cities and counties across the country.

the official offer was brought to Carloftis by Blount, it had been lowered to 4% for the floor.

The loan is for a period of five years, although payments will be amortized over 15 years. After five years, the loan will have to be renegotiated. "We intend to pay this loan off as quickly as possible," Carloftis said at the meeting. The bank will hold a mortgage on the building and building site.

There is no prepayment penalty for early payment of the note unless the funds are from an outside source, such as another financial institution.

The second reading of the ordinance will be held at a special meeting of the court on Monday, December 29th at 1 p.m. Then, a public hearing will be held in Frankfort on Tuesday, January 13, 2009 at 2 p.m. at the Department for Local Government (see legal notice elsewhere in this week's paper).

questioned the funding for the Perry and Amy Mink property, went on for several minutes and became so heated that, at one piont, Mayor Kirby told Smith he was out of order and that she would have him removed by police officer Brian Carter if he did not quit interrupting the meeting.

Council members Shelley Lewis, Sharon Saylor, Joe Mullins and Wayne Bullock all voted for the funding and council member Willy French, who was attending her last meeting of the council, voted against it. Council member Lonetta Daugherty was not present at the meeting.

After some further questions from Smith about the funding for the purchase of the Mink property, which adjoins the City Park on Williams Street, the council gave the Mayor authority to obtain \$175,000 in funding, also from KADD.

The Mayor again did not say how many years the loan would be for, only saying the city could take up to 40 years to pay it back, but that probably wouldn't be the case. The interest rate for that purchase will also be around 5%, Kirby said. Council members, Lewis,

Council members, Lewis, Saylor, Bullock and French, voted yes on the issue and council member Mullins abstained.

After a short presentation by Fire Chief David Bales and Sales Representative Scott Sizemore, the council voted unanimously to purchase a new fire truck for the city. the truck was needed because ho neither of the two city trucks system will draft (i.e., pull water from another source such as a pond, lake, pool, etc.), which will eventually cause the city's fire rating to go higher, increasing insurance premiums in the city.

Chief Bales told the council

The purchase price of the new truck, which is fully equipped, will be \$217,467.

Sizemore told the council that his company would provide a lease/purchase agreement for a ten year period, at a interest rate of 4.89 percent.

The council obligated themselves to a \$28,011.92 per year payment for the next ten years beginning in December of 2009.

Bales said the county truck, which his department uses on county runs, was in very good shape, but could not be listed as the primary truck for the city.

12 firefighters were in attendance at the meeting for the council's vote.

The council also voted to purchase a new backhoe for the city's water and sewer department at a cost of \$74,478.00.

Mayor Kirby told the council that \$100,000 had already been budgeted in the water and sewer budget this year for the purchase.

Water Superintendent Dennis McClure told the council, the current backhoe is a 1985 model and "stays torn up a lot."

And finally, the council voted unanimously to raise rates for the city's approximately 2,000 water customers by 3.5 percent.

City engineer Luther Galloway pointed out that the city had not raised rates for three years and that besides the backhoe, the current meter reading system is obsolete and would have to replaced.

"These automated reading systems are very expensive and will require significant capital expenditures to convert the existing meter reading system to utilize the automated equipment," Galloway told the council.

The engineer also said replacement of current equipment used by the department, is near the end of its useful life, and the cost to replace it could exceed \$500,000.

In other business, the council voted to give each city employee a \$25 Christmas bonus.

The next regularly scheduled meeting of the council is January 19th, when new council members Don Jones and Jackie Wayne Weaver will be sworn-in.



Jody Adams.





Request for Referendum The Pork Checkoff Program, was implemented September 5, 1986, as authorized by the Pork Promotion, Research and Consumer Information Act of 1985 (Act). The purposes of the Pork Checkoff Program are to:

• strengthen the position of pork and pork products in the marketplace

• develop and expand markets for pork and pork products.

AMS will conduct a Request for Referendum among eligible pork producers and importers of hogs, pigs, pork, and pork products to determine if those persons want a referendum on the Pork Checkoff Program. The Request for Referendum is being conducted as a result of a settlement of a lawsuit entered into February 28, 2001, with USDA and the Michigan Pork Producers Association, Inc., et al. (Plaintiffs). Eligible producers and importers will be able to participate from December 8, 2008, through January 2, 2009. Participation is voluntary, and only individuals who desire a referendum on the Pork Checkoff Program should participate.


